CONSENT DECLARATION REGARDING THE PROCESSING OF PERSONAL DATA UNDER REGULATION (EU) 2016 / 679

I have been informed of the provisions of Regulation (EU) 2016/679 of April 27, 2016,
on the protection of natural persons with regard to the processing of personal data and on
the free movement of such data, and repealing Directive 95/46/EC (General Data Protection
Regulation), adopted by the European Parliament and the Council of the European Union,
specifically:

The **right of access**, which gives the individual the right to obtain confirmation from
the Ministry of Education and Research as to whether or not personal data concerning them
are being processed and, where that is the case, access to the data and information on how
they are processed.

The **right to data portability**, which refers to the right to receive personal data in a
structured, commonly used format and the right to have those data transmitted directly to
another controller, where technically feasible.

The **right to object**, which allows the individual to oppose the processing of their
personal data.

The **right to rectification**, referring to the correction, without undue delay, of
inaccurate personal data.

The **right to erasure ("right to be forgotten")**, meaning the right to request that
personal data be deleted without undue delay where one of the following grounds applies:
the data are no longer necessary for the purposes for which they were collected or
otherwise processed; the individual withdraws consent and there is no other legal basis for
the processing.

The **right to restrict processing**, applicable when the individual contests the accuracy
of the data, for a period enabling the institution to verify their accuracy; or if the processing
is unlawful and the individual opposes the erasure of the data and requests restriction
instead.

I acknowledge that refusal to provide the necessary and requested personal data to
the Ministry of Education and Research will result in the inability to proceed with the
promotion procedure, and this cannot be held against the above-mentioned institution.

If the personal data provided are incorrect or change (e.g., change of residence,

marital status, email address, etc.), I undertake to inform the Ministry of Education and Research in writing and in due time.

I have also been informed that my data will be treated as confidential, in accordance with the provisions of Regulation (EU) 2016/679 of the European Parliament and of the Council of April 27, 2016, regarding the protection of natural persons with regard to the processing of personal data and the free movement of such data.
